#### The incorporation process includes

- → Obtaining of one qualified electronic certificate for the new Limited Liability Company's director(s),

(Note: As of 2015, the financial statements of the companies are submitted to the Agency for Business

Registers in electronic form provided with a qualified electronic signature of the legal representative.)

- > Preparation and notarization of documents

- > Company registration in the Business Registry Agency
- > Submission of initial applications to the Tax Administration and Local Tax Administration
- > Finding your company a favorably accounting services
